SENATE SIDE OFFICE NUMBERING SYSTEM

Building Prefixes: Russell (SR), Dirksen (SD), Hart (SH)

All rooms are three digits, the first digit including floor number and a prefix indicating office building. **Example:** Office, SH 522, is located on the fifth floor of the Hart building.

HOUSE SIDE OFFICE NUMBERING SYSTEM

Building Prefixes: Rayburn (RHOB), Longworth (LHOB), Cannon (CHOB)

RAYBURN: All rooms are four digits; the first is always 2, the second indicates floor. **Example:** Office 2404 RHOB, is on the fourth floor of Rayburn.

LONGWORTH: All rooms are four digits; the first is always 1, the second indicates floor. **Example:** Office 1233 LHOB, is on the second floor of Longworth.

CANNON: All rooms are three digits; the first indicates floor. **Example:** Office 233 CHOB, is on the second floor of Cannon.

POTENTIAL CONGRESSIONAL QUESTIONS

You can use this Q&A as a guide for what might come up in your meetings, we encourage discussing your own experiences and challenges wherever possible.

Q: We need to focus on submarines, why should I also prioritize carriers?

A: More than 50% of suppliers provide parts and services for both the aircraft carrier and submarine programs. Of those joint CVN/submarine suppliers, at least 60% say that a stable, consistent and predictable CVN procurement strategy is critical to their overall production efforts. (Data from industrial base assessment)

Q: What are the consequences if we don't provide adequate funding for CVN 82?

A: Delays in the procurement of CVN 82 would make it much more difficult to maintain a skilled workforce, access raw materials, sustain the network of sole-source suppliers, and deal with inflation. In fact, if CVN 82 is delayed, 40% of suppliers say they will need to layoff workers and/or deprioritize military shipbuilding and explore more commercial options.

Q: Why is this an issue that I should care about and advocate for?

A: Our national security and fragile shipbuilding industrial base depends on it.

Q: What can I do to help?

A: I ask that you show your active support for our legislative asks as you develop the FY2025 budget, review our survey data, and stay in proactive communication with the industrial base.
